# GOVERNANCE

## BOARD

The Sport SA Board can consist of six Directors elected by members and three Directors appointed by the Board. The President and Vice President are elected by the Board following the AGM each year.

### HON MICHAEL WRIGHT

#### PRESIDENT

*(Casual 2014 / Elected 2016 / Re-elected 2018 / Re-elected 2020 / Re-elected 2022)*

Michael is a former South Australian Member of Parliament and held the seat of Lee from 1997 to 2014. He was the Minister for Recreation, Sport and Racing from 2002 to 2011 and retired from politics in 2014.

Michael was a physical education teacher in Kadina from 1979 to 1985, before entering politics. Michael filled the casual vacancy position on the Sport SA Board before being appointed President in September 2015. Michael enjoys a passion for all sports.



### DR MARK GIANCASPRO

#### VICE PRESIDENT

*(2014 / 2016 / 2018 / 2020 Board Nominated)*

Dr Mark Giancaspro is a Senior Lecturer and practising commercial lawyer at the University of Adelaide Law School. He teaches and researches in contract law, consumer law, and sports law, and regularly provides training to sporting organisations across the country.

He has worked closely with FFSA and SASMA, and publishes widely on contracting issues in sport, particularly with respect to buyout clauses and transfer requests. Mark joined the Board of Sport SA in April 2019 and is passionate about helping the organisation advocate and deliver for its members and the sporting sector.

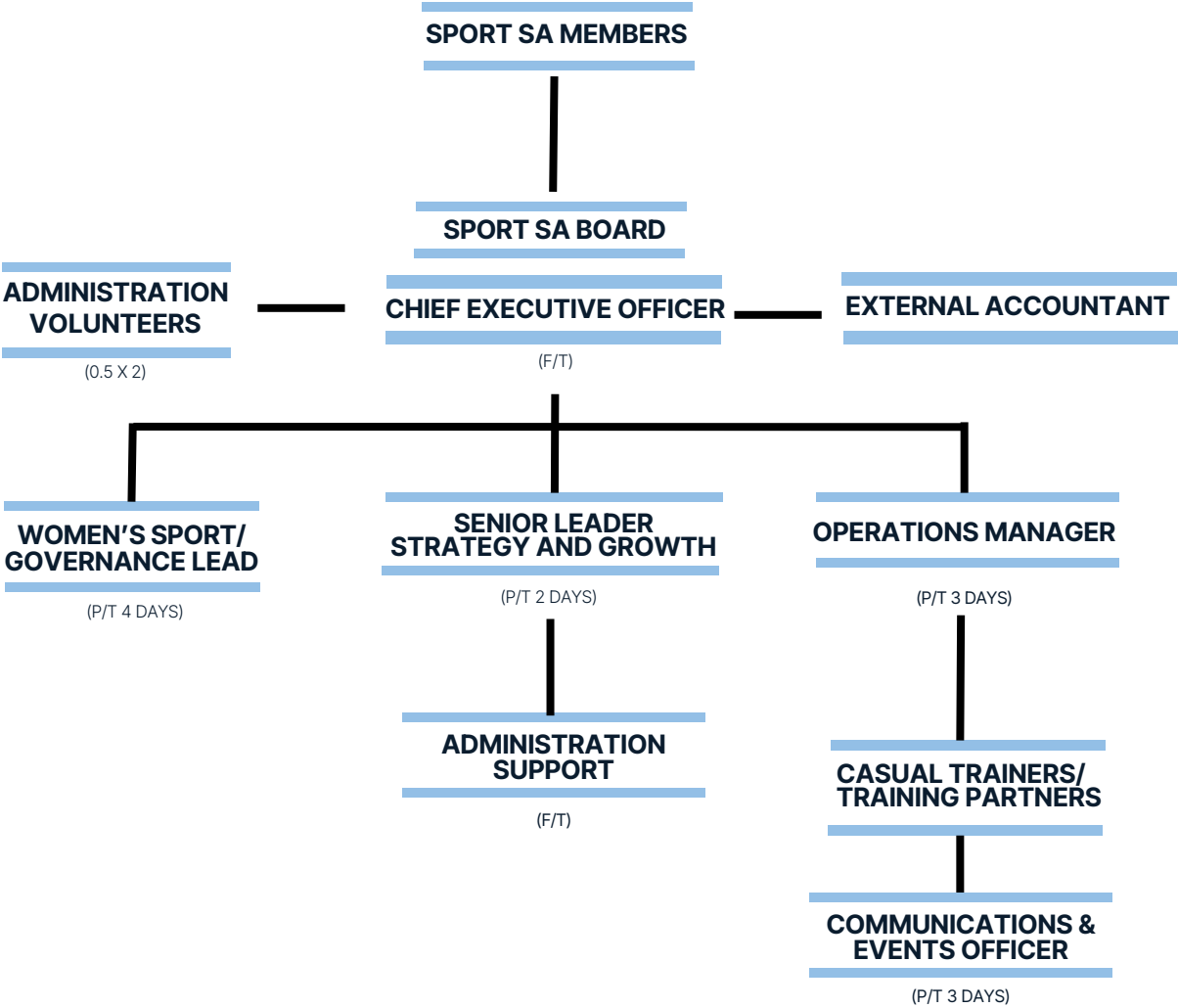

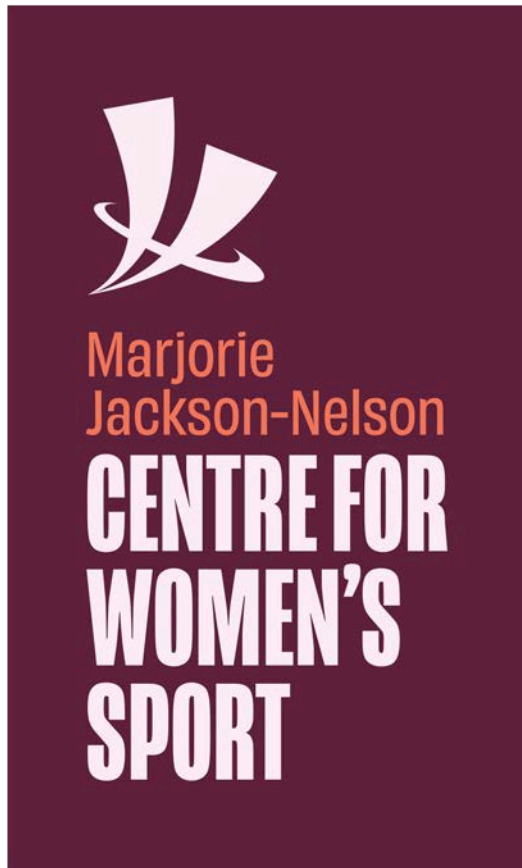
# ADVOCACY AND SUPPORT

Advocacy and support remains at the core of our purpose at Sport SA and this year we continued to work with government to ensure the voice of the industry was heard. Multiple meetings were held with Minister Hildyard to ensure industry voice and concerns are being heard. Meetings with the Opposition spokesperson also occurred and Sport SA was represented on the Local Government Sport and Recreation Forum, providing an avenue for understanding of issues at the local government level.

## In addition:

- Daily phone and email support to members on multiple issues.
- Regular meetings with Community Sport Australia and Sport Australia to advocate for the value of sport at the national level.
- Multiple presentations to the Women in Sport Taskforce advocating for more women in leadership positions across all facets of sport.
- An industry Jobs Board for members to promote vacant positions and industry to have a one-stop-shop for searching for vacancies.





The establishment of the Marjorie Jackson-Nelson Centre for Women's Sport has positioned South Australia as a national leader in women's sport; empowering and connecting athletes, coaches, officials, administrators and board members across sport to develop expertise and skills to realise their potential.

There are 8 core modules:

- Leadership
- People, culture & environment
- Media, social media
- Psychology, mental fitness
- Empowerment & connection
- Physical, well-being & self
- Financial literacy
- Social, nutrition, sport integrity, diversity and inclusion

and up to 4 elective modules in the program that are conducted over 12 months. Elective modules take place following the core modules. The electives are determined relevant to further gaps identified throughout the year and by the participants.

The inaugural program will conclude in November 2024, with the graduation of the inaugural participants hosted at Government House. There are 40 participants in the first program across 21 sports and a further 38 participants from across 20 sports in the second program. The second program will conclude in August 2025.

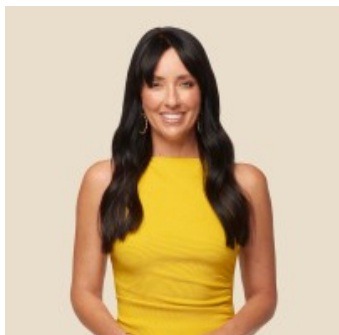

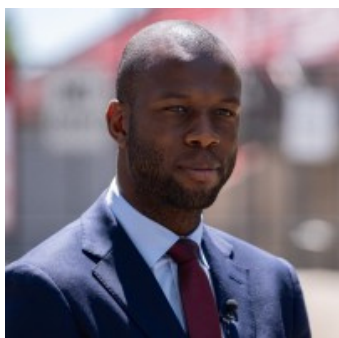

## EVENTS

Our Women in Sport Networking (WISN) events continue to connect, celebrate and acknowledge women in sport. Two WISN events were held this year with 360 guests attending across both events.

GOVERNANCE REFORM

The purpose of the program is to raise the governance maturity levels of State Sporting Organisations (SSO) in South Australia. The program provides professional development opportunities that aim to enhance leadership skills and governance capabilities of the SSOs. In addition, the program adopts and SSO led approach working with Boards and CEOs, to develop a governance action plan.

The governance action plan uses the Australian Sports Commission governance framework, that identifies nine principles and 40 guiding standards of best practice governance, to prioritise key goals to achieve over a 12-month period.

# FESTIVAL OF SPORT

In November 2021 then Opposition Leader, now Premier, Peter Malinauskas, announced an election commitment of \$1M per year for four years for Sport SA to lead capacity building of the sport and recreation sector. 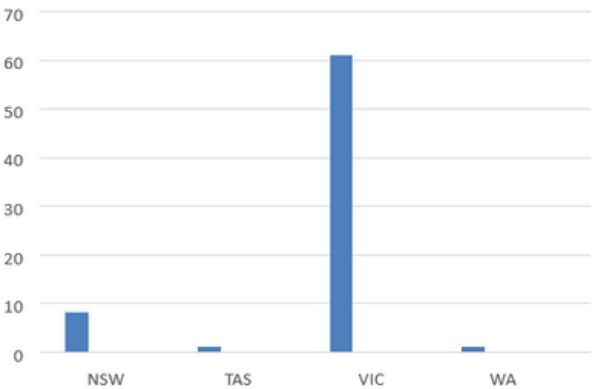

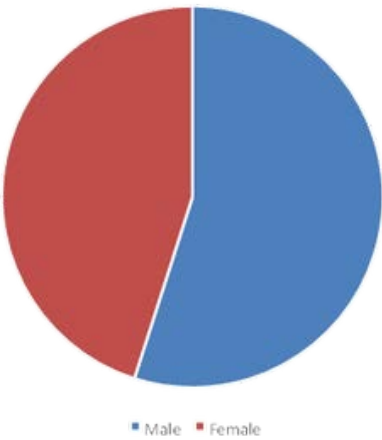

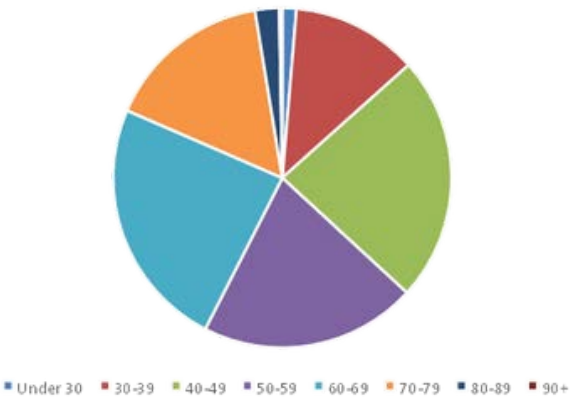
## Gender

## 1. Summary of Significant accounting policies

The principal accounting policies adopted in the preparation of the financial statements are set out below.

These policies have been consistently applied to all the years presented, unless otherwise stated.

**a.** This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act and the members of the Incorporated Association.

The financial report has been prepared in accordance with the requirements of the following Australian Accounting Standards:

AASB 1016: Leases

MSB1031: Materiality

AASB110: Events after the Balance Sheet Date

No other Australian Accounting Standards, Urgent Issues Group Consensus Views or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report is prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of noncurrent assets.

The following specific accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this report:

**b.** Property, Plant and Equipment Property, plant and equipment are carried at cost. All assets, excluding freehold land and buildings, are depreciated over their useful lives to the Incorporated Association.

**c.** Inventories are measured at the lower of cost and net realisable value. Costs are assigned on a first-in first-out basis and include direct materials, direct labour and an appropriate proportion of variable and fixed overhead expenses.

**d.** Finance leases are capitalised by recognising an asset and a liability at the lower of the amount equal to the fair value of the leases property or the present value of the minimum lease payments. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period. Lease assets are depreciated on a straight-line bases over their lease term.




